Swimming pool NOCis required

The promoter/applicant shall follow all terms & condition as per lease deed clouse-13 1. 5. 6.

Concent to operate from UPCB for STP is required. 7.

Lift Functional certificate (with A.R.D.) is required.

The Promoter shall publish in two news papers widely circulated in the area, invitings 8. suggestion/ objection regarding revision in the modified plan . In case of any objection/suggestion which is found justified bu Competent Authorith the Promoter shall be bound to modify the plans sanctioned by vide this letter at his cost. 9.
