1. **Introduction:-** GNIDA Invites Expression of Interest (EOI) from reputed and competent Contractors for the Maintenance & repairing of installed CCTV networking & Concerned Data System in GNIDA office building at Sector KP-IV, Greater Noida. The work includes testing of installed infrastructure related to CCTV network, listing of Unserviceable items/box, estimating the works involved in making the CCTV system serviceable & corresponding cost involved.
2. **Scope of work:-** The Scope of work includes, but is not limited to:
 - i) Testing of installed CCTV infrastructure.
 - ii) Listing of unserviceable items/Parts & new items required if any.
 - iii) Estimation of complete work including parts required for serviceability of the CCTV network & Concerned Data System & corresponding cost involved.
 - iv) Execution of Maintenance & repair works.
 - v) Proper presentation of working of Serviceable infra after the work.
 - vi) 03 years comprehensive AMC of CCTV network & concerned data System after successful completion of the Maintenance & repair works, excluding the defect liability period for the new items installed in lieu of old & unserviceable items during repair & maintenance work for a period of 24 months from the date of completion of repair.
3. **Tentative Project Cost:-** To be finalized as per Estimation submitted by the Competent authority.
4. **Eligibility Criteria:-** Interested Contractors must need the following criteria:
 - I) **Experience:-**
 - Minimum 05 years of experience in similar type of works
 - Successfully completed at least 3 projects of similar nature & complexity, each costing not less than Rs. 0.20 crore, or two projects costing not less than Rs. 0.25 crores or one project costing not less than Rs. 0.50 crores.
 - II) **Financial Capability:-**
 - Average Turnover of at least Rs. 0.75 crores in the last 3 financial years.
 - Solvency Certificate of at least Rs. 01 crores from a scheduled bank.
 - III) **Technical Capability:-**
 - Adequate resources, including equipment & Manpower.
 - Valid govt. registration for similar types of works.
5. **Submission requirements:-** Interested contractors must submit the following documents:

- I) Cover letter expressing interest.
- II) Organizational profile, including company registration details.
- III) Details of past projects (work orders, completion certificates).
- IV) Audited financial statements for the last 3 financial years.
- V) Solvency certificate.
- VI) GST registration & PAN details.
- VII) Declaration of no blacklisting.

6. Evaluation Process:- The submitted EOI's will be evaluated based on:

- I) Technical qualifications & experience (60%).
- II) Financial Strength (40%).
