#### 1- Introduction

Greater Noida Industrial Development Authority (GNIDA) invites expression of interest (EOI) from reputed & competent agency / firm for the beautification (Decorative Lighting) of various Entry & Exit Points and important Location of Greater Noida City.

#### 2- Scope of work

The Scope of work includes but is not limited to :

- a) Innovative Lighting Design
- b) Aesthetic Architectural lighting design
- c) Design of lighting Control system
- d) Lighting and control circuit details
- e) Preparation of conceptual lighting design
- f) Provision of Safeguarding of infrastructure to its maximum utilizable lift.
- g) Submission of detail BOQ and preparation with Documents
- h) Execution of work at site under engineer in charge supervision.

#### 3- Tentative Project Cost: To be decided after evolution of received EOI's by competing authority

#### 4- Eligibility Criteria:

Min 05 Years of experience in similar nature of lighting works.

Successfully completed at least 03 projects of similar nature and complexity each costing not less than Rs. 01 Crore, or 2 Project costing not less than 02 Crores, or one project costing not less than Rs. 03 Crore.

#### 5- Financial Capability:

Average Annual turnover of at least 01 crore in the last 03 financial years  
Solvency certificate of at least 05 crores from a scheduled bank.

#### 6- Technical Capability:

Adequate resources, including equipment & manpower.  
Valid Govt. registration for similar works.

#### 7- Submission requirement:

Interest agency / firm should submit the following documents:

- a) Cover letter expressing interest.
- b) Organizational profile, Including company registration details
- c) Details of past projects (work order, completion certificates) of the similar nature.
- d) Audited financial statements for the last 03 financial year
- e) Solvency certificate as issued by the competent authority
- f) GST registration & PAN Details.
- g) Declaration of No Black Listing.

## 8- Evaluation Process

The submitted EOI's will be evaluated based on:

- a) Financial Capability – 20 marks (maximum)
- b) Technical Capability – 10 marks (maximum)
- c) Experience in similar type lighting works  
05-07 Years – 20 marks  
07-10 Years – 25 marks  
10 Years & above – 30 marks (maximum)
- d) Presentation (40 marks maximum) –

Interested agency will arrange for a presentation, displaying work done in the past of a similar nature projecting aesthetics in lighting structure / lighting in accordance with list attached and clarifying the financial / cost evaluation for the each as described by the agency (25 marks maximum)

As well as the presentation will focus on how maximum utilizability of the proposed infrastructure (includes safety & security of the infrastructure against thefts and damages) can be achieved (15 marks maximum)
