महोदय,

अवगत कराना है कि ग्रेटर नौएडा औद्योगिक विकास प्राधिकरण द्वारा आवंटित बिल्डर्स प्रोजेक्ट्स के आवंटियों पर लगभग रूपये 6000 करोड की अतिदेयता है। प्राधिकरण द्वारा ऐसे आवंटियों, जो डिफॉल्टेड धनराशि का एकमुश्त भुगतान करने में असमर्थ हैं, के लिए प्राधिकरण की 113वीं बोर्ड बैठक दिनांक 04.12.2018 के अनुपूरक मद संख्या- 113/4 में अनुमोदित प्रस्ताव के क्रम में कार्यालय आदेश दिनांक 14.12.2018 के द्वारा रि-शिड्यूलमेंट की नीति दिनांक 31.01.2019 तक लायी गयी है। इस आशय से प्राधिकरण द्वारा सभी डिफॉल्टर बिल्डर आवंटियों को दिसम्बर, 2018 में सूचित किया जा चुका है तथा प्राधिकरण की वेबसाईट पर भी अपलोड है। इसके बावजूद भी कुछ ही बिल्डर आवंटियों द्वारा रि-शिड्यूलमेंट की नीति का लाभ उठाने के लिए आवेदन किया गया है।
