Newly added			<p>If the vendor uses old mechanical sweeping vehicles to initiate the work for the first four months, payment for the mechanical sweeping services will be 55% of mechanical sweeping component of rate quoted by bidder.</p> <p>Payment mechanism for vendor using old mechanical Sweeping machines:</p> <p>For the purpose of billing, 70:30 ratio shall be considered for manual and mechanical sweeping respectively. For example, assuming a bidder has quoted rate of Rs. 1000 per km and swept 240 km of main road and 190 km of service road in a day without attracting any penalty then amount of Rs 1,72,600 shall be considered for payment $[(1000*30%*240)*55% + (1000*70%*190)]$.</p>
