**NOTICE INVITING PROPOSAL FOR SELECTING AGENCY FOR OPERATIONS  
AND MAINTENANCE  
OF COW SHELTER IN GREATER NOIDA**

GNIDA invites proposal from the entities/ agencies/ NGOs/ organisation for operation and maintenance of cow shelter at Jalpura having about 2500 Govanshs as per scope of work described below and directives of UP Govt. The shelter consists of 7 sheds, 4 Food house, and 4 rooms for staff accommodation with 01 Guard Room.

Any proposal for operations and maintenance of Cow Shelter in Greater Noida without asking for any financial assistance, whether one time or recurring will be scrutinized by the evaluation committee constituted for the purpose, and permissions for implementation of the project will be granted based on the recommendation of the committee.

**The approval will be with following condition:**

1. The land assigned to successful bidder would not be used for any other activity except for approved project activities for 15 years.
2. The project proponent is not allowed to mortgage the land.
3. Access road, water supply, electricity connection, streetlight, drainage, sewer will be provided by the GNIDA up to the site.
4. For making the project self-sustainable, the agency may be entitled to sale or charge or utilize for the products and by products produced during the activities as per the applicable laws.
5. The agency has to bear all electricity charge, water charge, running cost (capex & opex), maintenance cost, site development (if any), & any other charge and liabilities at his / her own cost.

**Scope of Work:**

1. Proper identification of Govansh through ear tagging, or neck chain.
2. Routine grooming of cows, including bathing, brushing, and maintaining cleanliness.
3. Prompt and complete removal of animal waste/manure from sheds to prevent diseases and maintain cleanliness.
4. Provide daily feed, including Green Fodder, Wheat Straw (Bhusa), Concentrate, water, etc. to each animal per day in accordance with applicable veterinary norms and their specific body requirements.

Minimum feed requirement described below:

Feed Ingredient	Body weight in Kg		
	250 kg	300 kg	350 kg
Green Fodder (Hara Chara)	5 kg	7 kg	8 kg
Wheat Straw (Bhusa)	4 kg	4.5 kg	5 kg
Concentrate (DM, CP, TDN:90, 18, 70%)	1 kg	1.5 kg	1.5 kg

**Note:** 1. The stated quantity is intended for each animal on a daily basis.  
2. If green fodder is available than concentrate may be reduced  
3. Maintenance CP (350-500g) and TDN (3.5-4.5 kg) requirement.

5. Aiming for self-sustainability by effectively managing resources, techniques those are non-harmful to environment and animal friendly to be used, generating revenue through various products ensuring the financial viability of the project.
6. Employing enough experts' veterinary doctors for the proper health cover of all Govansh, in accordance with the guidelines and applicable laws. Officials and veterinary doctors from GNIDA reserve the right to visit the cow shelter at any time for spot inspections.
7. The bidder to deploy shift wise manpower including workers for the daily operations & maintenance of the cow shelter, security, etc.,
8. Exploring approved business activities such as selling milk and milk-related products, cow dung cakes, cow urine, and engaging in activities like making and selling cow dung gas, Biogas / Bio CNG and in addition to this other biodegradable waste may be used subject to approval from competent authorities. A separate Rent/lease agreement may be made as per applicable norms, in case of setting up of Bio CNG plant is proposed.
9. If the bidder intends to undertake any self-sustainable activities or plantation, then some part of land can be earmarked within the gaushala for green activities after taking written permission from GNIDA. No activities beyond the cow shelter area are permitted.
10. The bidder is required to transfer back both fixed and movable assets in same condition, including shed and land, to GNIDA upon the completion of the project duration.
11. In the event of non-performance of the specified activities or if any animal is found to be in poor health, GNIDA reserves the right to impose penalties on the bidder in accordance with applicable norms.
