3. End to End solution providers

These agencies will offer end to end solution or an integrated solution. This will involve collecting waste from the households, taking the waste to the facility, processing of the wet waste, incineration of sanitary waste, managing horticulture and dry waste and disposal of the rejects / inert. The main aspect of the work of these agencies will be this waste will not come in to the GNIDA's collection, transportation and processing channel.

4. Service Providers for other waste categories

These are authorized waste management agencies providing collection, processing and disposal services (as per applicable regulations) for different waste categories viz. Plastic waste, hazardous waste, e-waste, battery waste etc.

5. Experts in the field

a) Legal Experts

These agencies will provide guidance about the legal framework associated with the decentralized waste processing to citizens/ communities.

b) Environmental Experts

These agencies will provide guidance about environmental impact about the type of waste processing the citizens/ communities intend to choose. Additionally, they will also guide citizens/ communities on maintaining compliance with waste management regulations in force.

c) Decentralised Waste Processing

These agencies will be experts in offering guidance to the citizens / communities in selecting the best technology / machine / equipment to the citizens / communities based on the quantitative and qualitative analysis of their waste

d) Third party Auditors

These agencies will carry out audit of the waste processing carried out by the citizens / communities. The agencies will also certify that the initiatives taken by the generators are in accordance with the different statutory provisions by various authorities from time to time.

6. Community Awareness developers

These agencies will be members of the civil society who are keen on developing citizens' awareness about waste management by means of taking up cleanliness campaigns, performing street plays, organizing workshops for citizens.

7. Any other type

These agencies will not fit in the categories mentioned above but still want to get associated with GNIDA in the cause of increasing the compliance and efficiencies of Bulk Waste Generators for their decentralized waste processing.

Note:

- 1. Empanelled agencies will be responsible to send periodic reports to GNIDA in prescribed format.
- 2. Empanelled agencies shall ensure compliance with all applicable Laws, including all rules and guidelines prescribed in the regard, from time to time by any statutory authorities concerned.
- 3. Authority reserves the right to remove the agency from Empanelment and forfeit its security fee in event of non-responsiveness, non-compliance or non-performance based on citizen feedback and surveys/audits carried out by Authority.
