**EXPRESSION OF INTEREST**

**For Operation and Maintenance of Dog/Cat Shelter**

**1. Introduction:**

This Expression of Interest (EOI) is issued by Greater Noida Industrial Development Authority for the purpose of identifying qualified organizations or contractors to undertake the operation and maintenance of a Dog/Cat Shelter facility. The shelter is dedicated to the welfare of abandoned, lost, and stray animals and aims to provide a safe, clean, and caring environment.

**2. Objective:**

The primary objective is to invite interested parties to submit proposals for the effective operation and management of the Dog/Cat Shelter. This includes the shelter's day-to-day activities, including the provision of adequate animal care, health services, shelter maintenance, and ensuring compliance with local animal welfare regulations.

**3. Scope of Work:**

The scope of work for the successful party will include, but is not limited to:

- **Animal Care:** Ensuring the safety, comfort, and well-being of all animals, including feeding, cleaning, and exercising.

- Financial plan, including budget estimation for shelter operations.
- Any certifications or accreditations related to animal welfare or shelter management.
- References from previous or current shelter operations or similar projects.

## 6. Evaluation Criteria:

Proposals will be evaluated based on the following criteria:

- Experience and expertise in managing animal shelters.
- Ability to meet the operational requirements and scope of work.
- Financial viability and capacity to handle the shelter's operations.
- Approach to animal welfare and the community.
- Compliance with all regulatory requirements.
- Innovation in shelter operation and maintenance.


