1. INTRODUCTION

Greater Noida, spread over an area of about 380 sq. kms, is being developed as an integrated industrial town located about 35km from New Delhi. Greater Noida is divided into Sectors and villages which are divided into 8 administrative zones called work circles. The population of Greater Noida as per 2011 census was around 1 lakh. The current population is estimated to be approximately around 8-10 lakhs. It is estimated that the city generates approximately 300-350 tons of waste every day.

The Greater Noida Industrial Development Authority, hereinafter referred to as "GNIDA" invites Expressions of Interest (EOI) from qualified and experienced companies working in the field of sanitation for Construction, Operation & Maintenance of Public Toilets in Greater Noida Through Public Private Partnership (PPP) On Build, Operate and Transfer (BOT) basis. GNIDA is currently operating 41 public toilets for both male and female under the Build, Operate, and Transfer (BOT) model. The objective of this initiative is to enhance public amenities, particularly sanitation facilities, in Greater Noida through the establishment of 16 public toilets for both male and female, utilizing the Build, Operate, and Transfer (BOT) model.

2. KEY INSTRUCTION

- This EoI invitation document is not a Tender or Request for Proposal in any form and would not be binding on GNIDA in any manner whatsoever.
- GNIDA reserves the right to cancel the EoI invitation as a whole or in part without assigning any reasons.
- The Bidders are encouraged to conduct their own independent assessment, investigations, and analysis and check the reliability, accuracy, and completeness of the information at their end and obtain independent advice from relevant sources as required before submission of their response.
- GNIDA encourages interested bidders to contact the health department.
- GNIDA reserves the right to update, amend and supplement the information given in this document at its sole discretion before the last date and time of submission of the responses.
- Bidders should submit their response in English language and as per formats provided in the last section of this document. Submission not conforming to the instructions or prescribed formats will be rejected.

3. PROJECT DETAILS

With an aim to make India clean, the Swachh Bharat Mission (Urban) was launched by the Government of India on 2nd October 2014. One of the key goals of the mission is to make entire Urban and Rural areas of the country Open Defecation Free (ODF).

As per the goals and objectives of the Swachh Bharat Mission, GNIDA wish to undertake a project and on-board a qualified and experienced companies for Construction, Operation & Maintenance of Public Toilets on Build, Operate, and Transfer (BOT) basis.

Currently, GNIDA is operating 41 public toilets for both male and female under the Build, Operate, and Transfer (BOT) model. For this, concessionaire have been given advertising rights for revenue generation from advertisement panels fixed at the top of the public

toilet. However, GNIDA is now looking to establish at least 16 more public toilets having smart features making them more user-friendly, aesthetically attractive, innovative, and environmentally friendly.

4. SCOPE OF WORK

- Construct, operate and maintain the public toilet facility for at least 10 to 15 years which should include:
 - · western-style closet,
 - urinal,
 - wash basin,
 - · disabled-friendly and child-friendly infrastructure,
 - space for the caretaker,
 - facility to store large volumes of water,
 - waste-water disposal system,
 - sanitary napkin vending machine
 - area for keeping the luggage of users
 - exhaust system
 - dustbin
 - · all necessary fixtures required for sanitation facility.
- b. Apart from basic essential sanitation facilities, the public toilet complex may include other essential services such as a portable water ATM, sanitary napkin disposal mechanism, solar powered, revenue generation mechanism etc. Additionally, we welcome bidders to propose innovative and supplementary services to enhance the facility's offerings.
- c. Suggest a revenue generation mechanism through the proposed public toilets complex.
- d. A digital feedback mechanism and digital monitoring system.
- e. The public toilet facility should have appropriate indoor and outdoor lighting, separate entry for male and female.
- f. Provide provisions for advertising at the top or on the outer area of the complex
- g. Ensure the Public Toilets are neat and clean and free of debris, garbage through regular monitoring, maintenance.
- h. Please note that these are initial requirements; however, we encourage bidders to design the facilities in compliance with relevant standards and area specifications, ensuring they fit within the allocated area.

- Smart innovative Features: Offer specifics and distinctive attributes of the SMART innovative features incorporated into the toilet design.
- Digital Integration: Elaborate on the digital systems to be introduced for feedback mechanisms, monitoring, and any other relevant aspects.
- Environmental Stewardship: Detail your sustainable approach towards consumption
 of resources like water, electricity, etc. to operate these toilet facilities, if any. Also,
 elaborate on the strategies you will employ to reduce the project's environmental
