Sir/Ma'am,

I am filing this RTI to enquiry about the projects titled **Earth TechOne**, located at TZ-01, Sector Tech Zone, Greater Noida, Gautam Budh Nagar, Yamuna Expressway, Uttar Pradesh, and **Earth Sapphire Court**, located at Plot No. 48, Sector Knowledge Park-5, Greater Noida, Sector 3, Uttar Pradesh. ("Projects") that are being developed by M/s Alpha Corp Development Private Limited pursuant to the Corporate Insolvency Resolution Process of Earth Infrastructures Limited. It pertinent to mention that the land on which the said Projects are being developed was leased out by Greater Noida Industrial Development Authority ("GNIDA")

In light of the above, please provide following information / documents:

1. Copy of the application made to GNIDA for allotment of the parcel of land on which the said Projects are being developed. Furthermore, please provide elaborate details of the party(ies) who made such application for the allotment.
2. Copy of the allotment letter issued by GNIDA via which the land for the said projects was leased out to the concerned parties. Furthermore, please provide elaborate details of the party(ies) to whom such allotment letter was issued.
3. Copy of the requisite permission and no-objection certificate as mandated under letter number 2849/5/2039 dated 25.03.2013 for the Project Earth TechOne, located at TZ-01, Sector Tech Zone, Greater Noida, Gautam Budh Nagar, Yamuna Expressway, Uttar Pradesh. A copy of the letter number 2849/5/2039 is attached hereto and marked as Annexure No. 1.
4. Copy of the requisite permission and no-objection certificate as mandated under letter number IND/2007/649 dated 04.05.2007 for the Project Earth Sapphire Court, located at Plot No. 48, Sector Knowledge Park-5, Greater Noida, Sector 3, Uttar Pradesh. A copy of the letter number IND/2007/649 is attached hereto and marked as Annexure No. 2.

I hereby declare that I am an Indian citizen. I require the said information under the Right to Information Act, 2005. I request that the same may be provided to me at my below-mentioned address at the earliest. I have also attached a **Postal Order No. 52F0254** dated 14/7/22 of Rs.10/- as required under the RTI Act for seeking the said information and also undertake to pay any other legal dues in future also if required by the department, as and when communicated to me for providing me the said information. I am not filing the name of the Central Public Information Officer because I am not aware in whose name it will be issued, therefore, you are requested to fill the same.
