Sub: Reminder as advised by UTTAR PRADESH INFORMATION COMMISSION Letter No. R - 123187 Dated 04.07.2022 - regarding Information denied so far by the Greater Noida Industrial Development Authority under RTI ACT-2005.

Sir,

Further reference to the subject mentioned letter, Applications dated 10.02.2022 to the PIO and dated 10.03.22 to the First Appellate Authority with respect to certain information sought from the Greater Noida Industrial Development Authority is not supplied to me till date.

In the said context, as advised by the Uttar Pradesh Information Commission vide its letter No. R-123187 dated 04.07.2022, copy enclosed, I once again request the Greater Noida Industrial Development Authority to supply me the desired information with respect to Scheme Code-12 for the allotment of Flats in the Greater Noida as stated below within the stipulated time under the Act:

1. Date and year of Draw of Allotment of Flats under Scheme Code BHS -12.
2. Name of Successful Applicant for Allotment of Flat No. 304 (Second Floor) in Block No. 23 of Sector: OMICRON - 01, Greater Noida.
3. Name of Successful Applicant for Allotment of Flat No. 404 (Third Floor) in Block No. 23 of Sector: OMICRON -01, Greater Noida.
4. Provide me the certified copy of list of Draw of Allotment of Flats of BHS - 12 Scheme containing the name of both the successful Applicants with their respective allotted Flat Numbers of 304 (Second Floor) and 404 (Third Floor) in Block No. 23 of Sector - OMICRON - 01, Greater Noida.
5. Provide me Certified Copies of complete processed Note Sheet (s) on the subject also on which formal approval for Allotment of Flat Numbers 304 (Second Floor) and 404 (Third Floor) was obtained by the concerned Officer of the Competent Authority.
6. Intimate me the total cost payable towards providing all the above stated certified documents.
7. The complete information or part of it as sought above, if does not pertain to the Planning Department, in that case, it is clearly the job of the PIO/ Appellate Authority of the Planning Department to collect the desired information from the concerned Department/ Departments under Section 5(4) of the RTI ACT - 2005 and give it to the applicant within stipulated period.
8. In case, I do not receive the desired information within the prescribed period under the Act, I may have no other option but to approach the Hon'ble Commission, as advised by it, for appropriate action against the erring officer/ officers in the matter.
